UNIVERSAL LIFELINE TELEPHONE SERVICE
 (California LifeLine Service)

APPLICABILITY

Applicable to eligible residential customers for Universal LifeLine Telephone Service (ULTS), a.k.a. California LifeLine Program or LifeLine, furnished pursuant to the Moore Universal Telephone Service Act and in accordance with General Order 153. The Utility, as listed throughout this Schedule, is identified as the California LifeLine Service Provider in G.O.153.

The Utility shall provide federal credits for Lifeline Assistance as defined in FCC 47 C.F.R. 54.401 (a) (C) on a non-discriminatory basis to all qualifying low-income customers. The Utility's Lifeline service offering shall comply with all applicable federal laws, including but not limited to, 47 C.F.R. Part 54, Subpart E; The FCC's Lifeline Reform Order (Report and Order released February 6, 2012, WC Docket No. 11-42, et.al.), the FCC's Lifeline Modernization Order (Third Report and Order released on April 27, 2016, WC Docket No. 11-42, FCC 16-38, et.al), and any subsequent revision.

Within all exchange areas as said areas are defined on maps filed as part of the tariff schedules.
